

## Routes to Colonial Park, Somerset, NJ (note new location)

**From the North:** Take 287 South to Exit 12 for Weston Canal Rd toward Manville/S Bound Brook. Turn left onto Weston Canal Road. Take 3<sup>rd</sup> left onto Randolph Road. Turn right onto Schoolhouse Rd Turn left onto Mettlers Road. Colonial Park will be on the right.

**From the South:** Take I-95N to exit 7b to merge onto US 206North/bayard Ln/County Rd 533. Continue to follow 206 North. Turn right onto Amwell Road. Turn left onto Mettlers Road. Park will be on the left.

**From the West:** Take 78 East to Exit 29 for I-287 toward US202/206/I80 Morristown/Somerville. Keep right at the fork to continue toward I-287S. Keep left at the fork following signs for I-287 S/Perth Amboy and merge to I-287South. Take Exit 12 off 287 South for Weston Canal Road. Take 3<sup>rd</sup> left onto Randolph Road. Turn right onto Schoolhouse Road. Turn left onto Mettlers Road. Park will be on your right.

**From the East:** Take I-287 North to Exit 12 for Weston Canal Rd toward Manville/S Bound Brook. Turn left onto Canal Rd. Continue onto Weston Canal Road. Turn left onto Randolph Rd. Turn right onto Schoolhouse Rd. Turn left onto Mettlers Road. Park will be on your right.

### TRIAL HOURS: 8:00 AM each day until completion.

Inspection & Roll Call 8:30 AM Inspection will be allowed earlier than posted if inspection team is available. Early roll call by appointment. Field committee may have their hounds inspected early.

### ELIGIBLE BREEDS & REGISTRY:

Afghan Hounds, Basenjis, Borzoi, Greyhounds, Ibizan Hounds, Italian Greyhounds, Irish Wolfhounds, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, and Whippets. All entries shall be individually registered with the AKC or have been granted an ILP or PAL by the AKC.

*Azawakh, Cirneco dell'Etna, Norrbottenspets, Portuguese Podengo, Thai Ridgeback and Sloughis, 1 year of age or older, that have been recorded with the Foundation Stock Service (FSS), or that have been granted an Indefinite Listing Privilege (ILP) are eligible to enter lure coursing tests and trial for junior, senior and master courser titles but are not eligible for championship points, and are not eligible to run in Best in Field.*

**Junior Courser & Qualified Courser Test** - Hounds must be one year of age or older. QC Test must be passed prior to a dog being allowed to enter the Open Stake.

### STAKES OFFERED:

**Open Stake** - Stake Open to eligible hounds who have one or more of the following titles: An AKC Qualified Courser Cert, An ASFA or CKC Field Champion of record Certificate. **(A copy of the AKC Qualified Courser Certificate, ASFA or CKC Field Champion certificate must be presented with the first time entry.)**

### Veteran Stake

Any eligible sighthound that has met certification requirements whose age exceeds six years, except Irish Wolfhounds whose age shall exceed five years and Rhodesian Ridgebacks, Afghans and Whippets whose age shall exceed seven years.

**Specials Stake** - Open to all eligible hounds that have earned their AKC FC title. No championship points are awarded from this stake. **Field Champions are no longer eligible to enter in the Open Stake.** FC's can enter Veteran stake if they meet the age requirement. Points won from the Specials Stake count toward an LCX Title.

**Singles (Limited to 2 entries):** Open to all sighthound breeds approved to participate in AKC Lure Coursing trials. Hounds with breed disqualifications are eligible to enter. Hounds entered in the Singles Stake shall not be allowed to enter the regular stakes (Open, Specials or Veteran) at the same event. Each hound shall run the course alone. The order of running shall be determined by random draw. Judges shall score a dog's performance the same as a regular stake. Singles Stake entries from all breeds shall be combined to determine placements. Placements shall be awarded based on the combined preliminary and final course scores. The winner of the stake shall not be eligible to compete in Best of Breed and/or Best in Field courses.

**Note:** Hounds who have received a disqualification at an AKC trial are ineligible to compete until recertified.

**Note:** A hound who has received two dismissals at any time is considered disqualified and will need to meet requalification requirements before competing in competition.

### RULES & INFORMATION:

**All hounds will be checked for breed disqualifications.** Altered or neutered hounds may compete. Monorchid and cryptorchid hounds are NOT eligible to compete. Bitches in season and lame hounds will be excused. Hounds not present at the time of roll call will be scratched. Muzzles are not required; it is the owner's responsibility to determine if their hound should be muzzled.

**BEST IN FIELD WILL BE OFFERED** (IGs/FSS are not eligible to compete in BIF)

### AWARDS FOR JC TEST AND TRIAL

Dark green Ribbon for hounds successfully completing Junior Courser test.  
 First place Blue ribbon; Second place Red ribbon; Third place Yellow ribbon; Fourth place White ribbon; Fifth place Pink ribbon; BOB Purple/gold rosette. BIF Red/white & blue rosette.

**ADDITIONAL INFORMATION:**

BEST IN FIELD WILL BE OFFERED.

All entries must be one year of age or over on the day of the trial.

Bitches in season, hounds with breed disqualifications, and lame hounds will be excused.

Hounds not present at roll call will be scratched. Spayed or neutered hounds may be entered.

A fee of \$25.00 will be assessed for any returned checks.

There will be a \$5.00 fine for any loose hound on the field that is not part of the course in progress.

Course will be reversed for finals.

Persons exhibiting conduct detrimental to AKC/IWAGS/any hound(s)/other person(s) will be asked to leave the trial site immediately.

Lure machine is battery powered, continuous loop. Backup equipment is available. The lure will consist of highly visible plastic strips.

IWAGS reserves the right to alter the course as required by weather and/or field conditions on the day of the trial.

The field is not fenced.

Overnight RV camping is allowed at the park (Lot C), but hookups are not available.

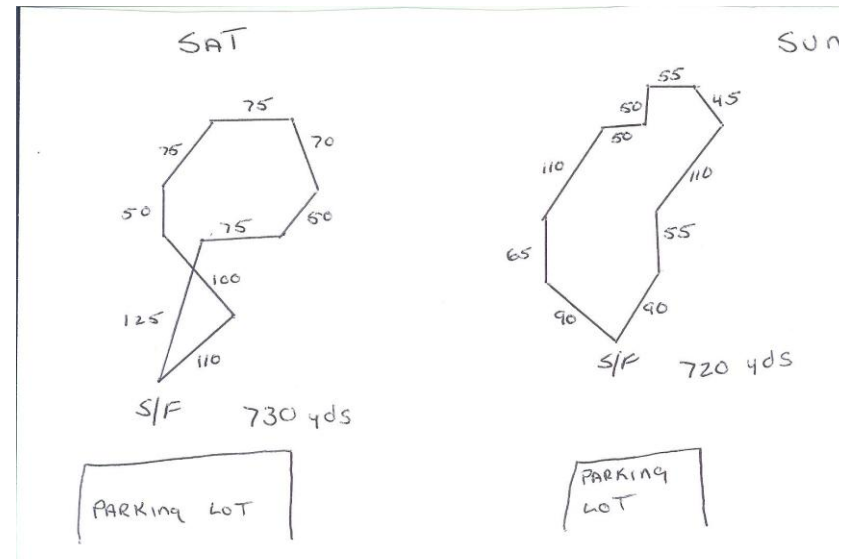
